East charge will be applied to incomes in Havana that deliver in other provinces and for the vacation between provinces. Is the same for all the categories. In vacation to the Havana does not apply, nor for rents between the offices of Havana. These charges are paid directly by the customers.

**INSURANCE AND COVERAGE**

All cars of the EXECUTOR are insured against shock, tipping, catastrophes and damage to third parties. THE EXECUTOR does not offer insurance to their customers. To protect its customers from the financial responsibility for damage to the vehicle, the EXECUTOR provides coverage against damage. The customer must eligible mandatory to this coverage to rent the auto. This coverage can be acquired through the payment of daily rates that vary depending on of the category of the vehicle and -defined in the prices public of REX.

## **DAMAGE COVERAGE**

### **1. Total economic relief for damage to the integrity of the car (Super CDP + TP):**

Accepting the Super CDP, the client is *completely* free of financial responsibility for damage to the vehicle.

**I.E.) This coverage is provided without deductible. In case of accident in the which do not violate the clauses in the lease, the customer shall be paid to the EXECUTOR surcharge one.**

The coverage does not cover loss or damage to Accessories, (brushes, antenna, mirrors , etc.) These charges will be paid directly by the client.

The coverage is not valid for a driver who is not registered in the contract since the beginning of the rental.

### **2. In case of accident or theft the customer should be:**

a. To immediately notify it to the competent authority nearest to the place of the fact or contact, free of charge, the services of the company's safety and protection (SEPSA), available in Havana, Santiago de Cuba, Holguín, Villa Clara and Varadero.

b. Report to the EXECUTOR

c. Take the necessary security measures with the vehicle avoiding further damage.

d. Fill the report of damage provided by a officer of the EXECUTOR.

### **3. Customer assumes the total costs by the damage to the car in the following cases:**

a. If the report of police or SEPSA, sets a rape of the clauses established in the contract of rental signed by the customer.

b. Use of narcotics, alcohol, or drugs that prevent the cabal performance of the customer or drivers additional duly registered in the contract of income.

c. If the auto is led by some person not registered on the contract of income.

d. In case that does not present a complaint police or SEPSA report, although he has accepted the coverage mentioned with earlier.

## VEHICLE RENTAL

1. **Form of payment** : To rent the car, how partial or total payment method, the customer can submit a credit card or pay in effective. Cards accepted are: VISA, MASTERCARD and American Express but they are issued by U.S. banks. In case of payment by the holder credit card of the contract must match with the holder of the card of credit.

2. **Airport Tax** : For all incomes with point of delivery at the offices of REX of airports of the country, be apply a tax Airport of 20.00 CUC to opening of the contract.

3. **Security Deposit** : Require one deposit for payments in cash or by credit card presented by the client. This deposit will be of 200.00 CUC for categories B, c and C and 250.00 CUC for the rest of the categories, **except the categories F, f and I for which will be of 450.00 CUC.** There is no additional charge , will return the value total deposited.

5. **Charges additional** : Closing of the lease, the customer must pay the executor all charges additional existing (penalties, additional drivers, fines of transit etc) including the coverage against damages.

6. **Fuel**: The car is delivered with full fuel tank and the total value will be charged at the beginning of the income of the tank at the price established by the Ministry of finance and prices both for the gallon of special gas as for the diesel. To ensure a correct servicing of the auto client should the return the car with tank the more vacuum possible.

6a. The client is responsible for the use of the correct type and quality of the fuel for the vehicle (gasoline special only).

7. **Additional drivers**: The possibility of two additional drivers (other than he who signs the contract) with license of driving with one year of experience as a minimum. In East case applied a office extra ascending to 10.00 CUC by everyone.

a. Additional drivers will be authorized to drive the vehicle, but may not pick up or deliver the car, receive refunds in cash or request extensions. These transactions with the EXECUTOR, the customer (holder of the contract) shall make them.



b. If the client stopped the vehicle responsible for the additional driver for return, shall be liable for the payment of any detected damage at the end of the rental, as well as other charges agreed upon at the start of the negotiation, without the right to claim. In addition, the EXECUTOR apply a penalty of 50.00 CUC.

c. The vehicle may be driven only by persons registered in the contract of lease.

d. When driving the vehicle leased by persons not authorized in the contract, the inspectors of the Ministry of tourism or the own business organizations is detected, check this violation, shall notify this situation in the contract to the customer with a **penalty ascending to the loss of the amount of the days earnings of use and the security deposit**, as well as they will proceed to withdraw the leased vehicle - Res 121/05 MINTUR, and. If the car is delivered by a person not authorized in the contract, Hedges are not valid

8. **Age minimum required for drive** : 21 years.

9. **Documents**: The client must present their passport and driving license with year of experience as minimum in the time of the income.

10. **Return of the car** : The customer must return the vehicle in the same conditions as was received on the time of your income.

11. **Technical car State** : The EXECUTOR will take all precautions to avoid failures in vehicles. THE EXECUTOR is not responsible for unforeseen fault attributable to the manufacturer, which can occur or appear, nor any consequences resulting from such fault.

12. **Signature of the contract** : The client must sign a contract at the beginning of the service which lays down in detail before exposed aspects . To return the car, the customer must sign the copy closed. However, if the car was abandoned, customer not wish to wait for your copy or for some reason not to sign that document, the EXECUTOR, has the right of apply the charges corresponding to the agreed to the home of the service, without that the customer have right of claim.

13. **Penalties** : The EXECUTOR cobra penalties by number:

a. In case of loss of the key of the auto: 200.00 CUC.

b. If key stays inside of the auto, for carrying the key customer, the EXECUTOR of spare cobra 50.00 CUC in the Havana and 100.00 CUC in the other of the provinces.

c. If the customer delivers the extremely dirty car or transport animals inside the car: 50.00 CUC

d. If the auto is handed by a driver additional: 50.00 CUC. and. By the loss of the registration of the auto: 120.00 CUC.

f. If auto is led or returned by a person not registered from the home of income, the EXECUTOR will penalize with the amount of the outstanding days of use and deposit of warranty.

g. Loss of the rugs: 50.00 CUC by the game.

h. Wallpaper of the car 200 CUC.

**NO SHOW:**

The tour operators pay a penalty up to the first day of income for each confirmed reservation and that the client not present to take the car.

**CANCELLATIONS:**

If after confirmed booking agency request cancellation within 15 days prior to the beginning of the service, shall be billed the penalty of half day's income.

**CLAIMS:**

You can claim for breaches of obligations agreed within 30 days natural following the fact that reason the claim.
